SURVEY RESULTS 2024


Global events bring together decision-makers from around the world to discuss crucial issues like education, climate change, and health. It is important that children are part of these discussions.



Children and young people were invited to participate in a survey to understand their experiences and ideas on how to make these events more child-friendly, inclusive, and impactful. Their feedback will help create guidelines for meaningful children's participation in global events.

What did we learn from the children and young people who filled out the survey (called respondents)? Find out in the summary below!

- 77 are female
- 47 are male
- 20 no longer study in school
- 6 have a disability
- · 6 live in a care facility or live with foster parents
- 4 live in a country other than which they or their parents were born
- · 2 had to flee their country because they were not safe there anymore.

Most of the respondents were older than 14 when they participated at a global event.






What global events did the respondents take part in?




What was the role of the respondents at the global event?


- 24 delivered a statement or presentation,
- 12 moderated/participated as a speaker in a panel discussion,
- 18 participated in a children's forum which was happening before/during/after the global event,
- 11 participated as a speaker in a side event,
- 7 performed during the event,
- 16 participated as a listener,
- 2 participated in another way.




How were the respondents selected to participate at the global event?

How many children participated at the global events besides the respondent?




What did the respondents like most about the global event they participated in?

We asked the children and young people to share more details about the global event they participated in.

Was the global event adapted in a way that children felt comfortable to participate?

A child-friendly meeting place was used for the global event.

76%

There was a safe, separate child-friendly space available for child participants to get prepared, socialise and chill.

71%

I felt comfortable and confident participating at the global event because they organized the discussions, workshops and activities in a child-friendly way.

74%

Was the global event inclusive, meaning that diverse group of children could participate?

I think all the children who were present at the global event could participate equally. This means that none of the children faced a challenge to participate because they had a different or special need.

70%

I felt that all children at the event were treated with respect and care. Every child at the event could choose how they want to participate.

We had enough time during the event to exchange and learn about each other.



I was asked for feedback at the end of the event.

Organizers of the global event informed us about the ways our views and suggestions were used.

There was a summary report about the global event which was accessible and understandable for children and it was shared with us afterwards.

Was their participation voluntary and did they agree to everything that happened at the global event?

I was clearly informed that I can change my mind and stop participating at any time that I wanted.

I could say no if I did not want to do something at the global event and the adults respected that.

Was their participation at the global event interesting for them?

I was interested in the topics discussed in the global event and I felt like it was connected to my life.

Did they feel good about the adults around them?

I felt like that the adults supporting my participation at the global event, had the right skills, knowledge and confidence to work with children.

I felt that adults supporting my participation did not try to influence what I wanted to say.

Did they feel respected?

I had opportunities to share my opinions, concerns and ideas and I was listened to.



My existing time commitments (to study, work, play, etc.) were respected and considered by the adults.







My culture, religion and values were taken into consideration by the adults (e.g. time for prayers, appropriate food provided etc).

Did they feel safe before, during and after the global event?

I felt safe and comfortable during the global event.



None of the adults at the global event made feel unsafe or uncomfortable in any ways.

Still asking about their feeling of safety!

I knew where to go for help if I felt unsafe during the global event.



There was a Safeguarding Officer or Focal Point whom I could go for help I felt unsafe or uncomfortable during the global event.



I did not have any negative consequences at home, in my school or in my city because I participated at this global event.



Nothing bad happened to me online, for example I did not receive bad or mean messages or comments on my social media because of my participation at the global event.



I was explained that photos and videos will be taken at the global event and I gave my consent OR I refused them and it was respected by the adults.



Did they receive accurate and enough information and got prepared for the global event?

I understood my role at the global event and what I could achieve with my participation.




I understood what this event was about, and the roles and responsibilities of everyone involved and key steps to prepare for the event.



I took part in meetings before the event to get prepared, including to prepare my intervention or speech and ask my questions.





What were the recommendations of the children and young people concerning child participation in global events?

1. There should MORE opportunities for ALL children to participate in global events. Children with special needs need to be included and provided with information in an accessible format.

GIVEN THE OPPORTUNITY TO
PARTICIPATE IN GLOBAL
SUMMITS AND CONFERENCES
WHICH CONCERN THEM."

"LINKS SHOULD BE SENT TO EVERYONE FOR EVERYONE TO APPLY AND GET A FAIR CHANCE TO ATTEND RATHER THAN BEING SENT TO LEADERS/ CUSTODIANS OF CHILD PARTICIPANTS."

"SINCE IT'S NOT EVERY CHILD WHO CAN PARTICIPATE PHYSICALLY, SO IF MORE CHILDREN ARE PROVIDED WITH SMART DEVICES AND PACKAGES TO HAVE ACCESS TO THE AMAZING INFORMATION BEING SHARED OR DISPLAYED THAT CAN SERIOUSLY IMPROVE CHILD PARTICIPATION."

2. The safety of the children participating at global events needs to be ensured among others by creating a safe and child-friendly environment and establishing safeguarding procedures and putting in place measures.

"ESTABLISHING CLEAR GUIDELINES, FEED BACK MECHANISMS, ADULT SUPPORT AND TRAINING, GLOBAL NETWORKING."

3. There should be more support including financial support and other type of assistance such as interpretation.

ARE NOT COMING BECAUSE THEY FEEL
DISCOURAGED WHEN NOT SPEAKING

"EVENTS SHOULD BE FINANCIALLY
ACCESSIBLE TO EVERYONE EITHER BY FULLY
FUNDING THE ATTENDEES OR PARTIALLY
FUNDING THE ATTENDEES AND IF IT'S SELF
FUNDED THE AMOUNT SHOULD BE PAYABLE
ESPECIALLY FOR US IN AN ECONOMICALLY
UNSTABLE COUNTRY"

4. Children at global events should have more opportunities for interaction between themselves and for fun.

"TO IMPROVE ON CHILD PARTICIPATION, THERE SHOULD BE A SPACE FOR THEM TO CONNECT WITH THEIR PEERS FROM DIFFERENT COUNTRIES IN AN IN-PERSON PROGRAMS TO GET THEM MORE INFORMED IN CULTURAL EXCHANGE FACTS."

"INCORPORATE
INTERACTIVE, FUN
ACTIVITIES: INCLUDE
GAMES, CHALLENGES, OR
CREATIVE WORKSHOPS
THAT ARE BOTH
ENJOYABLE AND
EDUCATIONAL. THIS KEEPS

LEARNING."

"CHILDREN HAVE SOCIAL SPACES
AMONG THEMSELVES WHERE
THEY CAN ORGANIZE
THEMSELVES WITHOUT FEELING
TRAPPED OR DEPENDENT ON THE
DECISIONS OF ADULTS."

"OVERALL IT'S JUST TO LET THEM BE CHILDREN AND LET THEM EXPRESS THEMSELVES, ALSO DON'T TREAT THEM AS ADULTS." 5. Child participants at global events need to be Respected and get recognition.

FULLY AND ANSWER
CHILDREN QUESTIONS."

"DO NOT INFLUENCE CHILDREN TO SAY
THINGS THAT WERE ONLY IN THE STATEMENT
THAT WAS GIVEN TO THEM. DO NOT ALWAYS
TRY TO KEEP THEM "IN LINE" BECAUSE
AFTER ALL THEY'RE CHILDREN. TAKE INTO
CONSIDERATION THEIR INSECURITIES AND
HOW IT CAN AFFECT THEM DURING THE
GLOBAL EVENT."

6. Child participation in global events is a process, it includes preparation and information-sharing and follow-up.

"CHILDREN BEFORE THE EVENT ARE GIVEN A BRIEF ANALYSIS OF WHAT WILL BE TAKING HAPPENING." "LET THEM BE A PART OF THE PLANNING PHASE AND SELECT TOPICS AS WELL AS FUN ACTIVITIES WITH YOUR GUIDANCE."

"FOR ME I PREFER FACE TO FACE (IN-PERSON)
MEETINGS IN THE FUTURE FOR CHILDREN AND
YOUNG PEOPLE AS THERE WILL BE ENOUGH TIME
TO DISCUSS AND SHARE IDEAS AS COMPARED TO
ONLINE MEETINGS, MORE ACTIVITIES AND
ENGAGEMENT SHOULD BE INITIATED AS THIS
SHOULD BE A CONTINUOUS PROCESS TO CREATE
THE CHANGE WE WANT TO SEE."

"CLEAR INSTRUCTIONS AND A DIRECT FORM OF INFORMATION. IT'S ALWAYS MORE DIFFICULT WHEN YOU HAVE TO GATHER INFORMATION FROM A LOT DIFFERENT SOURCES. ALSO SOMEHOW SHOW THE RESULTS OR PROGRESS THAT THE PERSONAL PARTICIPATION HAS HAD."

7. Child participants at global events want to see Real impact and action from adults.

"ALL THE DISCUSSIONS ON THE RIGHTS OF THE CHILD CONDUCTED BY THE UNITED NATIONS ARE NOW INVOLVING CHILDREN, IN VIRTUAL OR PHYSICAL SPACE. BUT, THE DISCUSSIONS ARE OFTEN NOT FOLLOWED BY A STATUS REPORT OF WHAT WAS DISCUSSED, AND ACTIONS TO BE TAKEN. THIS MAKES CHILDREN LIKE US FEEL THAT OUR VOICES ARE HEARD, BUT NOT RESPONDED TO."
